03/18/2022	For grades K-8, we had teachers use Interim 2 as a teaching tool, rather than an assessment. Teachers were instructed to evaluate the interim based on what skills were needed to answer each question. Teachers made a list of skills needed, and then scaffolded students to mastery on those skills utilizing "Do Now's," mini lessons, and quick drills during math. Student proficiency was assessed using informal and formal formative assessments in class. In this way, we focused on the progress we are making toward our end targets. Additionally, teachers received training in regards to backward design and backward planning with assessments. For math, this is done as a whole unit. Teachers evaluate the end targets and skills, and then examine the lessons to see alignment and scaffolding, as well as to prioritize their time on certain lessons over others. According to the unit tests in 3rd, 4th, and 5th grade in particular, we are seeing promising scores. In the latest math unit test in 3rd grade, 53% of students performed proficiently; in 4th, it was 41%, and in 5th it was 58%. Our goal is 45% proficiency, so most of those scores would indicate we are making progress toward our goal. Although we would like to see a higher score from 4th grade, this is the first unit test we have seen proficient scores in the 40th percentile and above, so we are confident that 4th grade is moving in the right direction. In 6th, 7th, and 8th grade, we have seen growth of 5% and 6% in proficiency over the last two school years, despite challenges during the Covid pandemic.	Benjamin Kriesch

Summary: "Authentic family engagement recognizes that all families, regardless of income, education, or cultural background, are involved in their children's learning and want their children to do well. Supports for families should be offered along a continuum that reflects the importance of meeting families where they are and supporting their engagement based on their child's needs (Epstein, 1995). Supporting families as partners in their child's education includes establishing a shared awareness of the strengths and challenges families face. It also acknowledges the importance of supporting parenting skills and establishing a shared understanding of best practices in supporting child and adolescent development. Supporting families as partners in their child's growth, development and learning requires tailoring of supports as these differ for children as they proceed from early childhood through high school and beyond. Programs and schools support families by providing adequate resources and funding for activities, training, and staffing to engage with families (Mapp, & Kuttner, 2013).
